Chairman's Report - H Gould

Gamlingay is historically a very well documented village and is has been a pleasure to serve as Chair this past year. It was an honour to lay a wreath on behalf of the Parish Council at the Remembrance Day ceremony last November at the war memorial. Pleased to see the completion of the Greensand Ridge signpost feature - this has involved a lot of work. We have trialed wildflower verges and meadows The Neighbourhood Plan steering group has made an enormous effort to submit the plan to the Inspector, who has agreed to move it to referendum with some modifications. Thanks to Simon Walder for continuing to manage the Speedwatch group- who are managing the moveable signage around the village, with the aim to educate drivers about the speed they are travelling. The Parish Council continue to support community groups throughout the year with grants including those to Gamlingay Football Club, Wildlife Trust and Gamlingay Jubilee Committee. Special mention to two long standing councillors who are retiring from the Council-Peter Webb served for 6 years and chaired the F&GP Committee and will be greatly missed, and Colin Smith who served for 12 years and has chaired many committees and chaired the parish Council. His legal expertise in business and planning has been of great benefit and we will all collectively notice his absence and recognize his contribution. The newly elected councillors will try to take on the custodianship demonstrated by Colin. His contribution is much appreciated.

General information

Except for August, the parish council meets on the second Tuesday throughout the year. The Finance and General Purposes committee meets on the fourth Tuesday each month. Both this meeting and the council meeting are preceded by a meeting of the Planning committee.

All meetings normally take place at the Eco Hub, Stocks Lane, Gamlingay. Agendas are posted on notice boards outside the Eco Hub, Stocks Lane, on Mill St and on our website www.gamlingay-pc.gov.uk

Since the start of the Council year in May 2021 the following meetings have been held:

- 11 Full Council Meetings
- 20 Planning Meetings
- 8 Finance & G.P. Meetings

Since May 2021 all meetings have been held in person.

In August 2020, the Parish Council was very pleased to be granted the Quality Award from the National Association of Local Councils in recognition that it had achieved good practice in governance, community engagement and council improvement. The award is valid for 4 years.

- The Old Methodist Chapel at Green End
- Cemeteries (Stocks Lane and St Mary's field)
- Maintenance of closed churchyards (St Mary's and the Baptist Chapel)
- Gamlingay Eco Hub (leased to Gamlingay Community Centre Ltd)
- Grass cutting of the above areas and verges within the village
- 51 street lights

Support Community Speed Watch, Gamlingay Community Safety Group, Grow Gamlingay and Neighbourhood Watch with their projects.

Community Transport - Install footpath on Mill Hill and seek funding for additional cycle paths/footpaths in the village

Continue to provide a library for Gamlingay

Lobby to protect green spaces such as the old First School field for community use Improve the website accessibility

The allotments are situated on the North side of Long Lane, adjacent to the track that leads up to the permissive path to Gamlingay Woods and 8 at Green End.
