Noted change in the side extension width/shape. No concerns expressed.

4.3 25A Everton Road Gamlingay Cambridgeshire. Replacement detached single storey outbuilding in the garden.

23/01727/HFUL-Refused

Proposed building significantly wider than the current garage building. Sited on route of an existing public footpath, which affects visibility and through views. Previous planning history -summer house, house extension, conversion of previous garage to accommodation. Proposal loss of additional parking space and additional two dwellings. Proposal has larger footprint than original dwelling. Proposed building width over dominates the garden/over development in the open countryside. Proposed dwellings are a significant increase in the footprint of the original garage.
